- **Logging:** Server logs are configured to exclude any personally identifiable information (PII). We use 24-hour log rotation and deletion policies to manage server logs efficiently.

### 4. Data Security:

- **Encryption:** All data transmitted between your device and our servers is encrypted using industry-standard TLS (Transport Layer Security) protocols. This ensures that your data is protected from interception and tampering during transmission.
  - **Storage Security:** Any data stored is protected using AES-256 encryption, which is one of the strongest encryption standards available.
  - **Access Controls:** Access to our systems and data is restricted to authorized personnel only. We use multi-factor authentication (MFA) and role-based access controls (RBAC) to enforce this. We use encryption keys managed by AWS Key Management Service (KMS) or a similar service.
